Report from the Ohio Attorney General's Office

He provided budget testimony for the agency in the Senate on April 30th. Chair Barreras, Stephanie Bostos-Demers, Darlene Newbern, Dale Olinger and Mary Turocy also attended the hearing. He is hopeful the Senate will approve the same funding level for the agency as the House. He expressed appreciation for the efforts of Chair Barreras and Commissioner Cespedes in assisting with the budget.

Lastly, Director Payton introduced Delali Nennonene, a summer extern from the University of Dayton (via former Governor Bob Taft). Delali will be a senior this fall majoring in political science. He is a member of the University Honors Program and the Dayton Civic Scholars among other activities. He also aspires to be a lawyer.

Remarks

The Commissioners welcomed the summer externs. They also congratulated the Chair on her reappointment to the Ohio Collaborative Community -Police Advisory Board.

Commissioner Peters thanked the staff for agreeing to participate in an upcoming outreach seminar in Dayton.

In honor of Public Service Recognition Week, Chair Barreras formally recognized and provided service pins to each Commissioner for total years of state service.
